CHILDHOOD LEAD SCREENING

Attention Primary Care Providers: Please review these guidelines to ensure that they are being met.

Public Health Law 1370-c requires that children between the ages of six months and six years be periodically assessed and screened for lead poisoning.

Specifically, 10 NYCRR 67-1.2 (a)(3) requires that primary care providers screen or refer each child for blood lead screening, at or around one and two years of age, preferably as part of routine well child care. In addition to such universal blood lead testing for one and two year olds, primary care providers must perform risk assessments for high-dose lead exposure for all patients between six months and six years of age, at each routine well child visit or annually for children who have not had such visits. Children found at risk must be screened or referred for lead screening. As part of routine care, primary care providers must also provide the parent or guardian of each child under six years old anticipatory guidance on the effects and sources of lead exposure and means to prevent it.

H. PYLORI TESTING

Effective 12/1/2009, Atlantis will no longer pay for Serum H. Pylori testing because it has minimal diagnostic value. <u>Stool or breath testing</u> for H. Pylori bacteria will remain covered.





Atlantis commences credentialing relationship with the Council for Affordable Quality Healthcare (CAQH)

Atlantis Health Plan has joined the more than 400 credentialing organizations currently participating in the Universal Provider Data-Source in offering providers an opportunity to streamline the credentialing process. To date, more than 740,000 providers have taken advantage of this unique online application.

Based on figures from a September 2004 Medical Group Management Association cost analysis, UPD is eliminating more than \$44 million per year or more than 1.5 million hours (the equivalent of 731 full-time employees) of provider and support staff time required to complete and send redundant application forms.

The Council for Affordable Quality Healthcare (CAQH) estimates the data-collection service has eliminated more than 1.1 million legacy-credentialing applications to date. UPD is supported by the American Medical Association, the American Academy of Family Physicians, the American College of Physicians, America's Health Insurance Plans, The Medical Group Management Association, The National Association of Medical Staff Services and other provider organizations, and recognized by a number of state legislators and insurance commissioners.

The National Committee on Quality Assurance, URAC, and the Joint Commission on Accreditation of Healthcare Operations has recently indicated that the latest version of the UPD application meets their respective standards.

Providers can participate at no cost. The data is protected and only released to the plans that you authorize. We encourage you to utilize our service and see firsthand how your administrative burden will be reduced.
