Network Updates

Hospital Closings & Terminations.

The following hospitals have closed or have terminated their relationship with Atlantis and therefore are no longer available to Atlantis Health Plan Members:

- · Coney Island Hospital located at 2601 Ocean Parkway, Brooklyn, NY. Effective July 28, 2009.
- Mary Immaculate Hospital located at 152-11 89th Ave. Jamaica, NY. Effective February 28, 2009.
 St. John's Queens Hospital located at 90-02 Queens Blvd. Flushing, NY. Effective February 28, 2009.
- Victory Memorial Hospital located at 699 92nd St. Brooklyn. Effective June 30, 2008.

Letters have been sent to impacted members informing them of their rights to request transitional care. Letters have also been sent to providers whose sole par privilege was with one of the terminated hospitals. The Provider Agreement requires certain providers to maintain at least one Atlantis participating hospital affiliation. Exceptions may be made if a provider without admitting privileges at a contracted hospital uses an admitting panel or can provide evidence that there will be another Atlantis network provider with admitting privileges who will admit their patient. Please call Provider Relations at 866-747-8422 if you have any questions.

If any of these hospitals are your only Atlantis participating hospital affiliation, you will need to make arrangements with Atlantis Health Plan to add a new participating hospital affiliation to your profile. Exceptions may be made if a provider without admitting privileges at a contracted hospital uses an admitting panel or can provide evidence that there will be another Atlantis network provider with admitting privileges who will admit their patient. Please call Provider Relations at 866-747-8422.

Atlantis Health Plan is no longer contracted with LabCorp and Quentin Medical Labs.

Atlantis members must receive all care, including laboratory services from an In-Network provider. LabCorp and Quentin Medical Labs are not In-Network providers.. It is the responsibility of Atlantis Contracted Providers to send lab requests to an In-Network laboratory provider for services. Please note: Laboratory services provided in the hospital setting are not covered unless in conjunction with an approved inpatient admission or ER visit.

In general there are two ways members access lab services:

- 1. The treating physician, sends the member's specimens to a laboratory provider for analysis. In this situation it is required that you as the Atlantis Contracted Provider use an In-Network laboratory provider.
- 2. The treating physician, refers the member to a freestanding laboratory facility. In this situation it is required that members are referred to a participating laboratory facility.

A Message from the Pesticide Poisoning Registry

The New York State Department of Health (NYSDOH) Pesticide Poisoning Registry (PPR) strives to increase reporting in the medical community of the pesticide-related illnesses and injuries and to develop interventions that reduce the risk of pesticide poisoning.

Poisonings may result from residential application of total release foggers, structural applications, lawn applications, in manufacturing and formulation settings, farm settings or any other location where pesticides are used and stored (e.g. kitchen cabinets, home improvement store shelves and stockroom areas). Because of the toxicity and easy availability, accidental or intentional ingestion of pesticides is an ever-present threat.

In 1990, pesticide poisonings were added to the list of reportable conditions in New York State as part of an effort to reduce the risk of health effects. Physicians and health facilities are required to report suspected or confirmed cases of pesticide poisoning.

A definitive diagnosis is not needed prior to calling. NYSDOH staff will investigate the reported case to collect information from the exposed individual(s) and to determine the health effects of pesticide exposure. Staff may intervene in situations where a continued risk of pesticide poisoning exists.

Physicians or other medical personnel with access to the patient's medical record should contact the NYSDOH PPR to report a case. Reports can be made by calling the tollfree number at (800) 322-6850 within 48 hours of treating any patients they suspect of having pesticide poisoning. Medical records and discharge summaries related to the pesticide exposure may be faxed to 518-402-7909.

Claims Submissions

In order for Atlantis Health Plan to better serve our physician community, please review these helpful tips for claims submissions:

- Use the most current CPT and ICD9 codes for 2009
- Ensure that the member's information is complete and accurate
- Ensure that your billing, service information and Tax ID are correc

Please note that the filing limit is 60 days from date of service. If the filing limit has passed, members **may not** be billed for services.

The 19 regional Cessation Centers funded by the NYS Department of Health educate and provide resources to health care providers about treating their patients for tobacco dependence. A typical training includes education about counseling techniques, prescription and over-the-counter pharmacotherapy, and changing office practices to better treat patients who are tobacco dependent. The Cessation Centers follow the Public Health Service Clinical Practice Guideline on Treating Tobacco Use and Dependence (updated May 2008).

In addition to on-site trainings, the Cessation Centers offer physicians, physician assistants and nurse practitioners an opportunity to earn 21 CME credits through a Performance Improvement Project. The 21 CME's are provided through the University of Buffalo. The Cessation Centers also sponsors a statewide conference call for 4-6 times per year. These calls feature lectures on various topics related to tobacco dependence treatment. It provides 1 CME credit, 1.0 Nursing Contact Hour, 1 CASAC Clock Hour, and 1 CUE for Respiratory Therapists.



Patients are driving generic drug use; doctors follow through


Virtually all doctors are worried that patients aren't filling their prescriptions. In addition to not filling Rx's, physicians are most concerned about patients' skipping doses, splitting pills, discontinuing other treatments, sharing prescriptions, and taking expired meds.

Physician survey on generic drug use, a survey from Epocrates, the clinical decision support

As the chart below shows, doctors' choices to prescribe generic drugs are often driven by their patients. In one out of 4 instances, physicians say either the patient prefers a generic or the patient asks for a generic drug. In 1 in 5 doctors, they "always" prescribe generics if available.

- Doctors are increasing their use of generics in prescribing:
- 58% of physicians say more patients have been asking for generic medications in the past six months
- 55% of physicians say they're writing more prescriptions for generic medications than they did last y
- Just over half believe that generic drugs are clinically equivalent to brand-name drug
- 42% believe that equivalence 'depends on the medication.

The most prevalent source doctors use for identifying generic alternatives to brands is mobile reference (remember, this is a survey among Epocrates-using physicians), followed by online drug reference, pharmacist recommendation, and health plan information (equally split between online and offline).

The survey polled 705 physicians who are registered with Epocrates and was completed in January 2009. Their specialties included primary care, cardiology, psychiatry, oncology, gastroenterology, and rheumatology.
